Re: 'In-principle' approval under Regulation 28(1) of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015.

We refer to your application seeking our "In-principle approval for the issue of 2,10,00,000 warrants convertible into 2,10,00,000 equity shares of Rs. 10/- each to be issued at a price not less than Rs. 25/- to non-promoters on a preferential basis."
